Purpose of the policy

This document is provided as an exams-specific supplement to the **Accessibility plan** which details how the centre ensures that it continues to improve all aspects of the physical environment of the school site, the curriculum and written information so that all students with a disability can take full advantage of the education and associated opportunities provided by Holmer Green Senior School.

Holmer Green Senior School recognises its duties towards disabled candidates as defined under the terms of the Equality Act 2010. In particular the duty to explore and provide access to suitable courses, submit applications for reasonable adjustments and make reasonable adjustments to the service the centre provides to disabled candidates.

This policy details how the centre facilitates access to exams and assessments for disabled candidates, as defined under the terms of the Equality Act 2010, by outlining staff roles and responsibilities in relation to

- ▶ identifying the need for appropriate arrangements, reasonable adjustments and/or adaptations (referred to in this policy as 'access arrangements')
- requesting access arrangements
- implementing access arrangements and the conduct of exams
- good practice in relation to the Equality Act 2010

The Equality Act 2010 definition of disability

A definition is provided in the current JCQ publication *Adjustments for candidates with disabilities* and learning difficulties <u>Access Arrangements and Reasonable Adjustments</u> (This publication is further referred to in this policy as <u>AA</u>)

Identifying the need for access arrangements

Roles and responsibilities

Head of centre

▶ Is familiar with, refers to and directs relevant centre staff to the annually updated JCQ publications including <u>GR</u> and <u>AA</u>

Senior leaders

Are familiar with the annually updated JCQ publications including GR and AA

Special educational needs coordinator (SENCo)

► Has full knowledge and understanding of the contents, refers to and directs relevant centre staff to the annually updated JCQ publication <u>AA</u>

Teaching staff

- Inform the SENCo of any support that might be needed by a candidate
- Provide evidence in a History of Need document

Support staff (for example, Learning Support Assistants, technicians, exam invigilators)

(where appropriate) Provide comments/observations to support the SENCo in painting a holistic picture of need confirming normal way of working for a candidate

Assessor of candidates with learning difficulties

(An assessor of candidates with learning difficulties will be an appropriately qualified access arrangements assessor/psychologist/specialist assessor)

Has detailed understanding of the current JCQ publication AA

Use of word processors

A word processor cannot simply be granted to a candidate because he/she now wants to type rather than write or can work faster on a keyboard, or because he/she uses a laptop at home.

The use of a word processor must reflect the candidate's normal way of working within the centre and be appropriate to the candidate's needs. (word processor policy)

Requesting access arrangements

Roles and responsibilities

Special educational needs coordinator (SENCo)

▶ Determines if the arrangements identified for a candidate require prior approval from the awarding body before the arrangements are put in place or if approval is centre-delegated

Exams officer

▶ Is familiar with the entire contents of the annually updated JCQ publication <u>GR</u> and is aware of information contained in <u>AA</u> where this may be relevant to the EO role

Implementing access arrangements and the conduct of exams

Roles and responsibilities

External assessments

These are assessments which are normally set and marked/examined by an awarding body which must be conducted according to awarding body instructions and/or the JCQ publication <u>Instructions</u> <u>for conducting examinations</u> (ICE).

Head of centre

Supports the SENCo, the exams officer and other relevant centre staff in ensuring appropriate arrangements, adjustments and adaptations are in place to facilitate access for disabled candidates to exams

Special educational needs coordinator (SENCo)

► Ensures appropriate arrangements, adjustments and adaptations are in place to facilitate access for candidates where they are disabled within the meaning of the Equality Act (unless a temporary emergency arrangement is required at the time of an exam)

Exams officer

▶ Is familiar with and follows the *Checklist for heads of centre and examination officers – The Equality Act 2010 and conduct of examinations* provided in the current <u>ICE</u>

Other relevant centre staff

Support the SENCo and the exams officer to ensure appropriate arrangements, adjustments and adaptations are in place to facilitate access for disabled candidates to exams

Other relevant centre staff could include:

- Staff responsible for IT or other specialist equipment that may need to be provided or adapted for a candidate
- ▶ Site staff responsible for **rooms and non-specialist equipment** (chairs, tables, clocks etc.) used for exams that may need to be adapted for a candidate
- Senior staff responsible for the centre's emergency evacuation procedures and the arrangements that may need to be in place for a candidate with a disability who may need assistance when an exam room is evacuated

Internal assessments

These are non-examination assessments (NEA) which are normally set by a centre/awarding body, marked and internally verified by the centre and moderated by the awarding body.

"Externally marked and/or externally set practical examinations taken at different times across centres are classified as 'NEA'."

Special educational needs coordinator (SENCo)

Liaises with teaching staff to implement appropriate access arrangements for candidates

Teaching staff

Support the SENCo in implementing appropriate access arrangements for candidates

<u>Internal exams</u>

These are exams or tests which are set and marked within the centre; normally a pre-cursor to external assessments.

Special educational needs coordinator (SENCo)

Liaises with teaching staff to implement appropriate access arrangements for candidates

Teaching staff

▶ Support the SENCo in implementing appropriate access arrangements for candidates

Facilitating access - examples

The following information confirms the centre's good practice in relation to the Equality Act 2010 and the conduct of examinations.

On a candidate by candidate basis, consideration is given to

- adapting assessment arrangements
- adapting assessment materials
- ▶ the provision of specialist equipment or adaptation of standard equipment
- adaptation of the physical environment for access purposes

The table provides example arrangements, adjustments and adaptations that are considered to meet the need(s) of a candidate and the actions considered/taken by the centre for the purposes of facilitating access.

Example of candidate need(s)	Arrangements explored	Centre actions	
A medical condition which prevents the candidate from taking exams in the centre	Alternative site for the conduct of examinations Supervised rest breaks	SENCo gathers evidence to support the need for the candidate to take exams at home	
		Supervised rest	Pastoral head provides written statement for file to confirm the need
			Approval confirmed by SENCo; AAO approval for both arrangements not required
		Pastoral head discussion with candidate to confirm the arrangements should be put in place	
		EO submits appropriate 'Alternative site for the conduct of exams form'	
		EO provides candidate with exam timetable and JCQ information for candidates	
		Pastoral head confirms with candidate the information is understood	
		Pastoral head agrees with candidate that prior to each exam will call to confirm fitness to take exam	
		EO allocates invigilator(s) to candidate's timetable; confirms time of collection of exam papers and materials	
		Invigilator monitors candidate's condition for each exam and records any issues on incident log	
		Invigilator records rest breaks (time and duration) on incident log and confirms set time given for exam	
		Invigilator briefs EO after each exam on how candidate's performance in exam may have been affected by his/her condition	
		EO discusses with pastoral head if candidate is eligible for special consideration (candidate present but disadvantaged)	

		EO processes request(s) for special consideration where applicable; incident log(s) provides supporting evidence Pastoral head informs candidate that special consideration has been requested
Persistent and significant difficulties in accessing written text	Reader/comput er reader	Confirms candidate is disabled within the meaning of the Equality Act 2010
	25% Extra time	Papers checked for those testing reading
	Separate invigilation within the centre	Computer reader sourced for use in papers (or sections of papers) testing reading OR up to 50% extra time awarded
		Original Form 8, signed by hand and dated, with Sections A, B and C completed; kept on file with body of supporting evidence, printed approval from AAO and signed data protection notice
Significant difficulty in concentrating	Prompter Separate invigilation within the centre	Gathers evidence to support substantial and long term adverse impairment
		Confirms with candidate how and when they will be prompted
		Briefs invigilator to monitor candidate and the method of prompting (call out his name to bring his attention back to the paper - confirms requirement for separate room)
A wheelchair user	Desk Rooms Facilities	Applies for practical assistant to help candidate set up wheelchair and other equipment in a practical assessment; approval automatically fails so awarding body referral lists the tasks that will be performed
	Seating arrangements Practical assistant	Provides height adjustable desk in exam room
		Allocates exam room on ground floor near adapted bathroom facilities
		Spaces desks to allow wheelchair access
		Seats candidate near exam room door
		Confirms arrangements in place to assist the candidate in case of emergency evacuation of the exam room
		Practical assistant cover sheet printed from AAO; to be completed by facilitator and inserted inside the candidate's work where this may be applicable to the assessment
